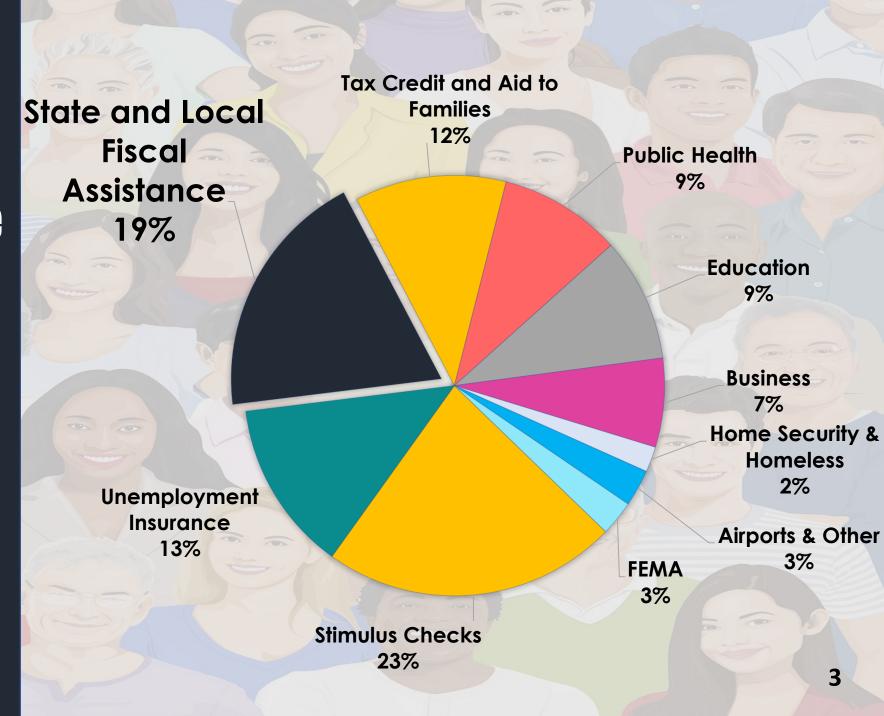

\$1.9 Trillion American Rescue Plan Act (ARPA)

Singed into law in March 2021





Background

- American Rescue Plan Act established the Local Fiscal Recovery Fund
- City of San Antonio allocated \$326.9 Million in two tranches
 - \$163.45 Million by May 2021
 - \$163.45 Million by May 2022
- Cities must obligate funds by December 2024 and spend by December 2026
- U.S. Treasury issued interim guidance, final guidance pending

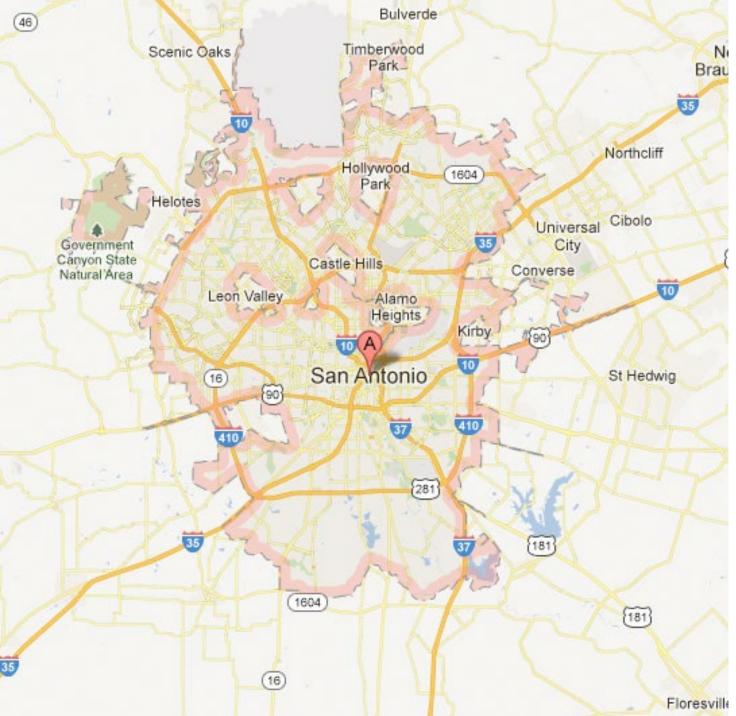

ARPA Reporting Revenue Loss Calculation

COSA ARPA Allocation	\$326.9M	
Total City Revenue Loss (From June 30, 2019 to December 31, 2020) ARPA Calculation — 18 Months	\$325.9M	

- City qualifies for funding using total revenue loss or programmatic guidelines
- City will utilize the Revenue Loss Category with intent to align with US
 Treasury Program Guidelines

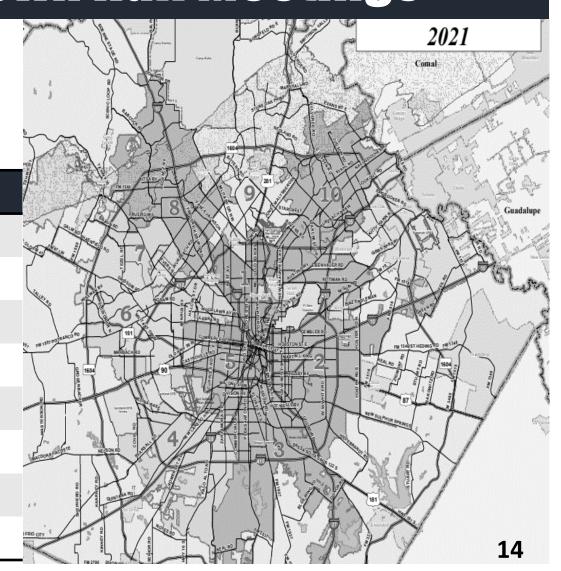

ARPA: HOME Investment Partnership Grant \$20 Million

Eligible Uses

- Rental Housing
- Tenant-Based Rental Assistance (TBRA)
- Supportive Services
- Acquisition and Development of Non-Congregate Shelter
- Nonprofit Operating and Capacity Building Assistance
- Administration and Planning

Proposed Spending Framework

- Purchase of a Hotel and Operating Costs for two years
- Rapid Rehousing for victims of domestic violence





Emergency Rental Assistance Grant (ERA1)

- US Treasury will be reallocating funds
- We anticipate that the City would be awarded additional funds based on record of distribution
- Waiting for release of application





Utility Assistance

- Ongoing discussions with SAWS and CPS
- Considering Residential Program for accounts currently on utility assistance programs and impacted by COVID-19
- Recommendation will be brought to City Council later this fall
