


700 Block Delmar District 2 | \$150,000

Construct new curbs and sidewalks.




700 Block Porter District 2 | \$150,000

Construct new curbs and sidewalks.




Roosevelt Avenue District 3 | \$5 Million

Add pedestrian walkway on Roosevelt Bridge between East Southcross and Riverside Street. *Note: This requires construction of either a new vehicle bridge with pedestrian walkway, or a separate pedestrian bridge to be co-located with existing vehicular bridge.*




Fredericksburg Road Sidewalks District 7 | \$2.1 Million

Fix sidewalk gaps and correct ADA issues between Balcones Heights and IH-10.




Loma Linda Drive Williamsburg to Babcock District 7 | \$700,000

Curbs, sidewalks and resurfaced roadway on Loma Linda between Williamsburg and Babcock Road (sidewalk on east side only).



Bexar Drive District 7 | \$ 115,000

Construct new curbs and sidewalks on the 500-600 block to alleviate flooding and allow a safe path for children (sidewalk on one-side only).
