COMMITTEE Meeting #2 Discussion Questions – Part 1

This memo addresses Bond Committee Member questions from the Parks, Recreation & Open Spaces 2022 Community Bond Committee Meeting #2 held on November 16, 2021.

<u>Submitted Committee Member Requests – November 17, 2021</u>

<u>District 1 Committee Member – Rachel Brehm</u>

1. Can UTSA provide a utilization percentage of the public usage for the Roadrunner Athletics Center for Excellence (RACE) that received \$10M from the 2017-2022 Bond package? For example, how many public events have been held since the center's opening in August, and is there an estimate of how many members of our community have utilized the space since it has opened?

Staff reached out to UTSA for assistance regarding response to this question. The funding agreement between the City and UTSA opened public access to both the athletic facilities at Park West and the Roadrunner Athletics Center of Excellence. Per the agreement, utilizing established rental costs, UTSA agreed to provide no-cost access for athletic competitions and community events for 40 days at Park West and 10 days at the Roadrunner Athletics Center of Excellence.

Due to the ongoing pandemic, limited indoor public gatherings have been held at the Roadrunner Athletics Center of Excellence, which follows NCAA and C-USA COVID-19 protocols for the health and safety of student athletes. It has still provided services for 350+ student athletes while abiding to all prescribed protocols. Additionally, while the grand opening for the Center was held on August 4, 2021, substantial completion did not occur until September 1, 2021. Progress is ongoing and UTSA anticipates an increase in community access and services in 2022.

During the fall, UTSA hosted various events including:

- Valero Texas Open staff and Trailblazers meeting
- UTSA Alumni Association Past Presidents meeting

- Tours of the Athletics Center of Excellence for the Athletic Business Show
- UTSA Alumni Association meeting
- Fellowship of Christian Athletes monthly meeting
- Networking events for Enterprise Holdings, US Dept of Homeland Security Secret Service Division, HEB, Northwestern Mutual, Vector Marketing and GM Financial
- Kinetic Kids volunteer training sessions
- Senior Games at Park West

Additionally, UTSA plans to host an increased number of varied community events, camps, clinics, and competitions in the near future.

2. Can UTSA also provide a percentage of the square footage of the RACE facility that is accessible for public use?

Staff reached out to UTSA for assistance regarding response to this question. More than 50% percent of the Roadrunner Athletics Center of Excellence (RACE) will be accessible for varied public use. City funding provided just under 25% of the Center's total funding. The City support was leveraged with significant fundraising to complete the Center. Also, UTSA Athletics provides ongoing maintenance and operation of the building at a cost just over \$700,000 per year.

District 5 Committee Member – Sarah Zimmerman

3. I would be willing to move to extend the meeting and stay longer OR add another meeting altogether in order to include all the citizens' comments AND have time to deliberate as a committee. The 'submit all the questions at the end' thing is an inadequate fix for the time constraints. I know many committee members agree we could extend a meeting or meet another time so that we don't have to shorten citizens' talking time or committee deliberations. I am going to urge our co-chairs to not use today's meeting as an excuse to shorten citizens' sharing time next time around.

This feedback has been captured and will be sent to the Co-Chairs.

4. I would like more information about which of the Activate SA funds can be spread out to transportation that Pauline talked about in citizens to be heard - especially concerning things related to the Greenway, since it's taking up such a big chunk of money so far.

At the October 27, 2021 Special Session, City Council approved the revised staff recommendations for total allocations for each proposition. Projects cannot be moved to another proposition at the Bond Committee level. The Bond Committee does have discretion to approve recommendations to modify projects and amounts within the proposition, so long as the total proposition total remains the same as was approved by City Council.

5. Palo Alto College did a needs assessment for their facility. Did UTSA do a needs assessment for their facility?

Staff reached out to UTSA for assistance regarding response to this question. Yes; Based on the availability and condition of the existing Convocation Center, the Athletics Department determined that a practice facility was necessary to accommodate various practices for volleyball, men's basketball, women's basketball and other, large-scale events. Furthermore, the construction of the practice facility will further advance gender equity/Title IX.

- 6. When is the bus tour? How can we provide input for which sites are on the bus tour? I would be interested in highlighting some south and west side parks as well as Mitchell Lake and Cassiano Park so that all members of the committee can see them.

 The bus tour is scheduled for Saturday, December 4, 2021. The Bond Committee will have a chance to comment on the lists of site visits from the staff recommended tour route. The City Manager's Office will be providing a formal list of sites to visit.
- 7. Do we have to fully fund the greenways in this bond? Would there be a way to prioritize some parts (the Salado creek part that's not connected, for example) and move some of the other parts to the next bond in order to free up bonds for other urgent needs? The 2022 Bond does not fully fund the greenway trails. The City Manager mentioned at Meeting #1 that the direction received from City Council during Council dialogue regarding the transition from Sales Tax funding was to fund the remainder of the trails over 2 bond cycles the 2022 Bond and the 2027 Bond. The Ft. Sam Houston connection of Salado is funding with existing Sales Tax funding and the connection from Salado (South) to the San Antonio River Mission Trails is funding through the Bexar County/San Antonio River Authority approved funding plan. The 2022 Bond prioritizes trail projects that complete the overall ring of the trail system, increase overall connectivity, and access via 10-minute walk.
- 8. I would like to hear more about the struggles with parking at Pearsall Park.

 Pearsall Park is a regional park with many popular amenities that can place stress on available parking during peak hours. There are currently 5 parking lots at Pearsall Park with over 300 total parking spaces at lots by: trailhead, dog park, sports field area, and 2 lots at the main park. As part of the 2017 Bond, a new parking lot near the Leon Creek Greenway trailhead will come online with over 140 new spaces, in addition to other amenities. The project is currently under construction and anticipated to be completed by early calendar year 2022. The proposed Master Plan for the park identifies future development to include parking to support a sports complex (baseball and softball).
- 9. I would like to hear more about a citizen's advisory committee for the Parks and Rec department that includes environmental organizations when it comes to the layout and design of parks projects once the bond is passed.

The Parks and Recreation Department currently has three citizen advisory boards:

- Conservation Advisory Board serves in advisory capacity to provide input and guidance to staff and City Council on the development of the Edwards Aquifer Protection Program charged with protecting the quality and quantity of water recharging into the Edwards Aquifer through the protection of land over the sensitive recharge and contributing zones via conservation easements or fee simple purchase. The board is composed of nine seats appointed by the City Council to include representatives from the San Antonio River Authority and Texas Parks and Wildlife Department.
- Linear Creekway Parks Advisory Board serves in advisory capacity to provide input and guidance to staff and City Council regarding development of linear parks along major creeks and rivers and their tributaries in the San Antonio area. The board reviews

- trail planning and project status for the Howard W. Peak Greenway Trails System. The board is composed of eleven seats appointed by the City Council.
- Parks and Recreation Board serves in an advisory capacity to staff and City Council, regarding parks, community recreational facilities and services, needs and desires, and recreation programming. The board is composed of eleven seats appointed by the City Council and ex-officio representatives from the San Antonio Parks Foundation and the San Antonio Conservation Society.

10. I would like more information about how we can advocate for a bike park, BMX or mountain biking, in the westside, possibly in the new addition to Normoyle Park, or even at one of our more underdeveloped parks that may have the space.

The 2022 Bond Staff Recommended Project includes \$6,750,000 to make Normoyle Park a regional park to add additional developed green space in an area of town that is underserved in this manner and historically has severed industrial use purposes and can accommodate a variety of amenities to include dog park, covered skate park, butterfly garden, restrooms, picnic area. There is sufficient proposed funding to include a bike challenge area and modify other potential amenities. The Bond Committee will recommend a list of proposed parks and total amount for City Council's consideration within the approved proposition totals. If the Bond Proposition passes during the election in May 2022, specifics such as exact amenities are determined during a public input design process for each Bond Project. Based on public input, final scope and specific design amenities are finalized before the project begins construction.

11. For the sake of transparency, I am a teacher at Tafolla Middle School in SAISD. I would be interested to know this info from other Bond Committee Members.

No Staff Response Needed.

<u>District 7 Committee Member – Elena Guajardo</u>

12. From the last bond, not all projects have been completed. With increasing materials costs attributed to the pandemic, is there enough money to complete the projects and will there be any projected savings from the last bond?

As it relates to the 2017 Bond Proposition 3 – Parks, Recreation, and Open Space, there are no known budget shortfalls other than the Phase 2 ask for Hemisfair Civic Park. Staff continue to scope projects to the available budget, in alignment with the public input design process. Any savings encountered in projects have been minimal and the practice remains to spend dollars to the lowest point possible by adding small features such as drinking fountains or site furniture to spend any remaining small amount of funds.

13. Looking at other revenue sources, does the Parks Foundation contribute any revenue to the parks? I have to learn more about the Parks Foundation.

Yes. The San Antonio Parks Foundation (SAPF) is a non-profit organization, which provides enhancements to city parks. SAPF receives corporate and foundation grants and individual gifts to support various park projects and enhancements. Through an agreement with the City, SAPF hosts three large-scale events on behalf of the City (Celebrate San Antonio: New Year's Eve, July 4th Celebration, and Jazz'SAlive) for which the proceeds are utilized to support the operating budget and additional park projects. Over the past few years SAPF has funded improvements at Pearsall, Pytel, and MLK Parks. Most recently, they have funded and

implemented an augmented reality application which guides a tour through the Japanese Tea Garden.

14. On the ActivateSA website it notes that the Executive Director, Kari Kuwamura, "returned to serve her hometown as the Program Manager for the City of San Antonio's Park and Recreation Department". Is this true? Per their Facebook, she started with ActivateSA on September 2, 2021. When did she leave the COSA and what was the timeframe for the 10 ActivateSA Bond proposals to be received to COSA? If this is a "volunteer led" group as per their website, is the Executive Director a paid position and if yes how do they raise funds to pay her?

Staff reached out to ActivateSA to assist in response for this question. ActivateSA was formed in 2019 by a coalition of volunteer community advocates working to implement bold new active transportation infrastructure through advocacy, consensus-building, and technical design. At this time, members began conversations with community members, neighborhood associations, and major institutions to find potential projects and connections to make their neighborhoods more active and accessible for all ages and all abilities.

ActivateSA is a nonprofit organization whose operations are funded by San Antonio area charitable foundations. Kari Kuwamura was recently hired as ActivateSA's first Executive Director after an intensive nationwide search. Previously, Kari served as a Program Manager for the City of San Antonio Parks and Recreation Department where she was responsible for managing education and recreation-based curriculum for community centers across San Antonio. Kari separated from the City in mid-August 2021 and had no interaction with ActivateSA or their affiliates until her initial interview. ActivateSA submitted their proposals to the City in June 2021, before the hire of the Executive Director position.

15. Has the Parks staff done a cost summary to add shade over the shallow part of the Woodlawn Lake Pool? I've been told from the D7 staff that there is not enough money from the \$450,000 Park Maintenance Budget to pool upgrades to include shade on the kids shallow part of the pool. I'm asking for a cost estimate for shade over the shallow part of the pool. Perhaps similar to Elmendorf Pool.

Staff estimate the cost to provide a shade canopy over the shallow part of the Woodlawn Lake Park Pool to be approximately \$390,000 - \$400,000. The estimate includes a 30' x 60' trussed, four-post, fabric shade canopy with that spans the width of the pool. The estimated cost is site specific and is impacted by the large truss required to span the width of the swimming pool.

- 16. Asking for a cost estimate for shade over the playground equipment near the bathroom. Staff estimates approximately \$120,000 to provide shade over the playground adjacent to the Woodlawn Lake Park Pool and \$170,000 to provide shade over the playground near the Woodlawn Lake Park Island House.
- 17. Please forward a note in the 48-hour response that the Cassiano Park restroom renovations was \$350,000 from the FY 2022 Parks schedule maintenance budget. Kudos to Parks for that completion!

From FY2015 – FY2020 more than \$365,000 have been spent on improvements such as parking lot repairs, security lighting, basketball resurfacing and new picnic area improvements.

In the current FY2022 Parks and Recreation budget, Parks prioritized a scheduled maintenance project at Cassiano Park for restroom renovations in the amount of \$350,000 to expand restroom capacity within the existing footprint. Additionally, the District 5 Council Office allocated \$230,000 in FY22 funding for shade at the pool.

18. Medical Center Greenway Trails, I see they are requesting \$1.9M. They came last night so just confirming this is a new ask? I did see in regional or D8.

There was no public comment in Meeting #2 regarding an ask for Medical Center Greenway Trails ask of \$1.9 M. Staff recommended \$3,250,000 of 2022 Bond funding for development of the Medical Center Area Park, a project request from the San Antonio Medical Center Alliance whom presented as an outside agency in Meeting #2. This project also includes an additional \$2,850,000 in leveraged funding from the San Antonio medical Foundation and the Medical Center Alliance. Additionally, there is a \$11,919,490 project as part of the linear greenway trails recommendation that would link the new park site via Huebner Creek. In the Meeting #1 Staff Presentation on November 9, 2021, the Medical Center Area Park is listed as a District 8 Project and the Hubner Creek to Medical Center Trail and Park Phase 1 (Floyd Curl to Eckhert) is listed as a District 7 & 8 project.

19. Just a question for me, Old Spanish Trails Park request. I know this project to be a large retention pond and have large soccer facility. Was there a previous vision to build this out or is this a new request?

The proposed scope and request for funds in the 2017 Bond by the Urban Soccer Leadership Academy, a sports tenant at Old Spanish Trails Park, constructed: conversion of the Stormwater Basins (originally constructed by the County and deeded to the City) into 10-acres of sports fields with lighting, new soils and turf, bleachers, maintenance equipment storage, new irrigation system and fencing to open a pedestrian connection from Renner Drive to the VIA bus stop on Fredericksburg Road. The request for funds in the 2022 Bond from the same organization includes additional park improvements for improved safety and wellness, a Cafe College and Wellness Center, a Concessions, Restroom, Office and Storage Building, and a Pavilion. The proposed scope as part of their 2022 Bond request was not included in the Master Plan developed for the 2017 Bond but provides additional safety measures in response to having occupied this new park and encountering security challenges. This project request is currently not on the Staff Recommendation list but can be included with Bond Committee action.

20. Again a question for me, # 34 Citywide Golf Course Improvements. In my term I think I remember we sold Golf facilities to a non-profit so that Parks was getting out of the Golf business. Did we sell to this Municipal Golf Association of San Antonio? If yes, are they not making enough to do the improvements and rehab?

In 2007, the City entered into an agreement with the Municipal Golf Association – San Antonio to operate and maintain the 8 municipally-owned golf courses. These golf courses remain City property, and capital improvements to courses are shared by both MGA-SA and the City.

- 21. I'm going through my notes and the new asks are
 - Greater Love Ministries for \$1M
 - Cassiano Park I think the ask is \$5M

- Something about softball but I did not get a specific park or location(s)
- #32 Mitchell Lake Wetlands \$12m
- #43 Medical Center Greenway \$1.9M

22. Do the co-chairs of the committee get to vote?

Per advisement of the City Attorney's Office, Committee Co-Chairs can vote.

23. It was voiced at the end of the meeting there is not sufficient time for bond members to comment or have questions. Can it be established that more time be added to our last meeting so there is time for discussion and vote. Suggest no staff overview and give the committee time to discuss and vote. Would this need to be a motion from a committee member?

A motion can be made to extend the meeting. This feedback has been captured and will be sent to the Co-Chairs.

District 9 Committee Member-Arthur Downey

24. I hope staff will be providing us with a synopsis of the organizational and individual projects that were discussed last night, to include whether it was a new ask or a project already on our proposed funded list (and if on the list if it involved an increase in funding).

Attachment A is a summary of public comments received including project requests, support or opposition of projects, and any other general comments.

District 9 Committee Member - Talat Shah

25. UTSA Athletic Practice Facility - Is there a portion of this project being funded by the UT system? If so, how much? If not, why not? Their materials state additional funds will be raised through philanthropic sources.

The \$10,000,000 request for the UTSA Basketball & Volleyball Practice Facility is to fund a portion of the total facility cost of \$29,500,000. Information received from UTSA states that the remaining amount is to be funded by Bexar County and potentially through financing by the Roadrunner Foundation.

Staff reached out to UTSA for additional assistance regarding response to this question. No portion of the UTSA Basketball & Volleyball Practice Facility will be funded by the UT System. Texas public universities cannot use Legislative state revenue bonds or the UT System Permanent University Fund (PUF) for intercollegiate athletic facilities. The Texas Legislature will not authorize, nor appropriate funds, for the operations or building of intercollegiate athletic facilities. Legislative funds (revenue bonds) can only be used for the construction of classrooms and laboratories. Under the Texas Constitution, the PUF can only be used for the construction or rehabilitation of classroom buildings and laboratories.

26. BMX in Pearsall Park - Point of clarification. BMX was included in the prior bond cycle, but the citizens group is asking for an additional \$500,000 to also build a Pump Track. Is that correct?

The addition of a BMX facility has been a potential amenity improvement outline in Park's Master Plan most recently updated in 2012. Every time bond funding has been identified for the park to date, the public input process has driven the elements of the Master Plan that were to be included as part of a bond project. The staff recommended \$1,500,000 of 2022 Bond funding allocated for Pearsall Park could fund the addition of a BMX facility, subject to the approval of the community during the public input design process. A bicycle pump track is currently under construction as part of the 2017 Bond project and is scheduled for completion in late Spring 2022.

27. The Restoration Mile Proposal at McAllister Park - Would this be a new additional project and not included in the original proposed allocation of \$1.25 million to McAllister Park? Or could it be included in the McAllister allocation?

The project mentioned during Citizens to be Heard was an alternate suggestion to an existing Mud Creek trail project currently in design and scheduled for funding as part of the Bexar County/San Antonio River Authority 10-year program. The project design included input from the community during a public meeting held on October 4, 2021.

- 28. Linear Greenway Trails How much of the \$110 million dollar allocation would actually build out the original Peak Greenway Plan and how much is for additional new projects? The Howard W. Peak Greenway Trails System is a growing network of hike-and-bike trails that include a "ring" around the city, as well as a myriad of neighborhood infill connections to the larger "ring." Neighborhood infill connections and other projects such as lighting pilot projects have varied based on land acquisitions, community and neighborhood input, and other factors. Projects C and D on Attachment B are ActivateSA projects that align with the City's Howard W. Peak Greenway Trail System plan. On Attachment B, Priority Projects H, K, L, M, N, O are projects that have been added recently in an effort to continue to enhance the trail user experience, increase connectivity, and access via the 10-minute walk initiative.
- 29. There seem to be some projects which would be relevant to other bond categories. For example, the proposed Medical Center Area Park has some drainage considerations as I understand it. Similarly, the community centers such as those proposed for District 1 and District 4 might be shared between Facilities and Parks. Is there a mechanism to coordinate funding across areas as appropriate?

Staff have placed projects into the propositions that they have traditionally been located, or those where most of the use is identified. At the October 27, 2021 Special Session, City Council approved the revised staff recommendations for total allocations for each proposition. Projects cannot be moved to another proposition at the Bond Committee level. The Bond Committee does have discretion to approve recommendation to modify projects and amounts within the proposition, so long as the total proposition total remains the same as was approved by City Council.

Other Questions Submitted by Committee Members

30. How can we better understand or have delineated the linear greenways via the transportation/streets/sidewalks vs. parks? Was it accurate that Parks Dept. would become responsible to maintain the transportation/streets/sidewalks?

Attachment B identifies the linear greenway trail projects that are COSA vs. ActivateSA as well as part of the Howard W. Peak Greenway Trails System (park) or street connections. The City's Public Works Department will maintain the street trail connection projects as Public Works oversees all Right-of-Way.

31. What bike trails and bike courses exist in San Antonio now, is there a map?

The Howard W. Peak Greenway Trails System is a hike-and-bike system that currently consists of 86 miles of completed trail and trail maps and trailhead locations can be accessed on the Parks and Recreation Department's website at www.saparksandrec.com. The Parks and Recreation also has a memorandum of understanding with South Texas Off Road Mountainbikers (STORM) to construct and maintain a number of off-road biking trails at a number of City parks including McAllister Park, O.P. Schnabel Park, Pearsall Park, just to name a few. Additionally, the approved Conceptual Plan for O.P. Schnabel Park includes a network of paved bicycle trails. Eisenhower Park has natural-surface trails that are planned but have not yet been funded.

Within the City's parks system, there is a bicycle pump track at McAllister Park, a cyclo-cross track at LBJ Park and a bicycle pump track and bicycle skills area currently under construction at Pearsall Park anticipated for completion in early calendar year 2022.

32. What was the cost for shade at Elmendorf? Wondering if there are any cost estimates that have been done at Woodlawn Lake pool.

The cost for the shade canopies was estimated to be at \$150,000 for the two canopies. Staff estimate the cost to provide a shade canopy over the shallow part of the Woodlawn Lake Park Pool to be approximately \$390,000 - \$400,000. The estimate includes a larger 30' x 60' trussed, four-post, fabric shade canopy with that spans the width of the pool. The estimated cost is site specific and is impacted by the large truss required to span the width of the large swimming pool.

Ray Morales – District 5

- 1. First, I'd like to comment that it was a great disservice to our passionate organizations and citizen speakers to not be able to ask them questions after their presentations, and I would have preferred to extend our meeting time. That is why we are here, to listen to our community. In the future, I'd like the co-chairs to present to the committee the options for extending the meeting time, add an additional meeting, or have a virtual conversation at another time.
- 2. As some of the presentations did not address whether they were asking for new funding or, had been included on the requested parks project list, I'd like to request that city staff inform the committee about this request made of the presentations.
- 3. It is very confusing to have separate lists of the Nov 5, Parks, Recreation & Open Spaces (67 projects) and of the HWP Greenway Trails (16 projects), especially when the funding amounts AND the project names are different. Could a column be added to the Nov 5 list, (or latest list) identifying which projects are on the HWP Greenway Trails list? Realize that HWP designation may appear more than once as some HWP projects are on several council districts.
- 4. What was the original HWP bond funding and total projects requested, as a speaker mentioned in her presentation? Was this before Activate SA got involved?
- 5. How many of the HWP Greenway Trails (\$110m) are new parks, trailways, or connections? Not inclusive of improvements to existing, such as lighting, relieving trail congestion, user conflicts, etc..
- 6. How is security and maintenance going to be addressed, and funded for these new HWP Trail Projects? Will this require additional police patrols? Which city departments (or private org) will be responsible, or involved?
- 7. How many of the 67 projects requested for the 2022 parks proposition have links or are connected to any other of the 2022 bond propositions, such as Drainage, Facilities, Streets & Bridges?
- 8. Is there any new revenue, such as concession sales, venue rentals, parking fees, etc., projected from any of the 67 projects? Will the city keep the revenue or have agreements with concessionaires or vendors been made?
- 9. I would also like to advocate that a park user count, maybe a random count, or a remote electronic/digital counter for ea park or facility be employed. Some parks get heavy, or light use on different days or times. This would help determine maintenance, policy, security, updates required, etc., as well as what areas of the city need more recreational spaces.
- 10. Which of these projects mitigate flooding, are made inaccessible by low water crossings, or are made unusable by terrain that is affected by inclement weather?
- 11. What are the consequences for postponing some projects, such as Maverick Creek Greenway or Bonnie Conner Park? Will postponement affect drainage, ecology, safety?
- 12. If we get general or generic answers to any of these questions because the projects are not designed, are nascent and details are not available, why do we, as a city have a process that seeks funding for

projects that have not been appropriately studied? I realize this is more of a City Council policy question but, the money and the debt obligations are real. City staff has to manage the money and has input into the process. There are too many opportunities for over funding, under funding, cost over runs, delays of design, unforeseen circumstances, corruption, etc., etc. *The city will still need to pay off the bonds, but the money will not have been spent on the projects as planned and promised.*

Chuck Saxer – District 8

- 13. Why are some ActivateSA trails projects being considered under the Parks Bond rather than the Streets & Sidewalks Bond when they are along city, county, state roads rather than creeks or other Greenways? I understand only Council can move a project from one category to another. How can we have clarity on this in the future before it gets to the Bond Committees?
- 14. An example is ActivateSA Flyway Trail would use 281 and Wetmore as the route. How is this a Parks Project (Greenway with current or future trees, and other Park features) rather than just a sidewalk and bike path which should be included in Street & Sidewalks?
- 15. Hays Street Bridge Trail appears to run along Hays Street using existing right away. How can a Greenway Trail be added? How will it go under I-37 and what all does that entail? What will it connect to?
- 16. Brooks Greenline Connection appears to be design only trail using a lot of city streets. Will it connect to Brooks Park? Isn't this just a cut through between a planned SARA trail segment and Mission Reach?
- 17. Since Trails along Streets and Sidewalks are considered Parks, will the Parks Department also be responsible for patrolling and maintenance? Will the 15mph Speed limit still apply? How is this going to work?
- 18. What are the plans to connect Huebner Creek to Medical Center with other Greenway Trails?
- 19. From November 12 Memo Why is Brackenridge only CW Park and Hemisfair only Regional Park while numerous others should be considered? What does it take to get these classifications? What is the distinction between Parks and Facilities

Sean Christopher – District 10

Many cyclists expressed opinions about mountain biking. However, can we get it clarified that there are four main projects where the attention is desired most? These being:

- 20. completion of the Mountain Bike skills area at McAllister Park. The 2017 bond paid for the pump-track, but fell short of money for the outer perimeter where a progressive jump loop was planned to go. Is it anticipated that the 2022 bond will pay for the completion of this?
- 21. The purchase of the golf course land near O.P. Schnabel Park that is intended for an even larger Mountain Bike Skills Park. This doesn't seem to have a line item anywhere. The amount of funding is only a number, which makes its use vague. Can the people know when this will move past the planning stage?

- 22. With the new Greenway expansion complete along the north side, Eisenhower Park is a target for Downhill and Enduro trails for Mountain Bikers, but again, I can't find a line item for this other than another amount for funding without mention what it will be used for. Can it be added along with the others?
- 23. Pearsall Park had a lot of advocacies mentioned from many citizens to be heard. However, again, we are unsure as to how much funding is being asked for besides the mentioned paved path and when any Mountain Bike Skills Area will move past a planning phase. Can that also be addressed?
- 24. Lastly my final question brings up an issue of public safety. A very energetic opinion was expressed about the safety of the trail system towards the end of the night. I occasionally see vehicles for Park Police driving down the road. Why are they not in the parks? Shouldn't they be on bikes patrolling the trails? Where is the funding to keep people safe? Is there any initiative to install downlighting along any trails? Even some form of lighting would help deter crime. Many other cities have this, why not us?

Not so much a question, but an obvious statement addressing Sunken Garden Theater: If a sizeable amount (half) of funding is not aimed at proper stewardship to maintain facilities, it will only fall into a state of decay all over again. Building with sustainable materials is one thing, but everything has a lifecycle. There must be some commitment included to pay for the maintaining of such facilities.
