### **OVERVIEW**







Small Business Economic Development Advocacy (SBEDA) provides access to City contracts by promoting the participation of eligible local small, minority, and woman-owned businesses (S/M/WBEs) to address historically documented disparities. In FY 2022, the City of San Antonio, allocated \$290 million to 529 unique local small, minority, and women-owned businesses (S/M/WBEs), representing the largest dollar spend in the history of the SBEDA program.

The program's ordinance was updated in 2016 as a result of the 2015 disparity study which recommended program expansion and improvements to further eliminate marketplace discrimination. Local minority and woman-owned business (M/WBE) utilization on City contracts has grown from \$5.5 million or 13% to \$246 million or 47% since 2011.

The data in this appendix represents actual payments during City of San Antonio FY 2022 (October 1, 2021 – September 30, 2022) to S/M/WBE prime contractors and subcontractors participating on City contracts in which the SBEDA program applied. SBEDA annual reports are considered snapshots to assess program strengths and weaknesses.

## **Disparity Study**

In Fiscal Year 2022, SBEDA commissioned a disparity study to ensure minority and womanowned businesses have equal access to contracting opportunities, pursuant to its mission. The study included focus groups, surveys, and prime contractor data collections. The study report is anticipated in Spring 2023. Information from the report will be utilized, in tandem with business community feedback, to guide potential SBEDA program amendments throughout the latter half of 2023.







## SBEDA M/WBE UTILIZATION PROGRESS


FY 2011 - SBEDA Ordinance Revisions | FY 2014 - SBEDA Race-Conscious Application









## EMERGING SMALL BUSINESS UTILIZATION


#### FY 2022 ESBE Payments


