DECLARING HONORABLE CITY MAYOR RONALD ADRIAN NIRENBERG OF SAN ANTONIO CITY, TEXAS, UNITED STATES OF AMERICA, AS AN ADOPTED SON OF THE CITY OF BAGUIO, PHILIPPINES.

WHEREAS, the City of Baguio, pursuant to its desire to become a progressive local government unit, has been establishing sisterhood ties with domestic and international cities, forged through independent and mutual desires for such twinning and sisterhood arrangements;

WHEREAS, the City of Baguio in accordance with Ordinance Numbered 42, Series of 2008¹ has established the guidelines in establishing sisterhood and twinning where the City is committed to establishing sister city alliances with other cities of like qualities for the purpose of fostering long-term mutual partnerships that assist communities gain a national and global perspective to the challenges they face through planned cultural, educational, business/trade and humanitarian assistance exchanges;

WHEREAS, the Honorable City Mayor Ronald Adrian Nirenberg of San Antonio City, Texas, United States of America, honored the City of Baguio by his visit, together with his delegation, to officially establish the Sisterhood Ties between the cities on 10 to 14 July 2023;



Unanimously adopted.


