CANDIDATE ELIGIBILITY REQUIREMENTS

- **MUST** be a citizen of the United States;
- MUST be at least 18 years old;

Office of the City Clerk Internet Posting Requirement Posted 2024.03.18

- **MUST** be a qualified voter of the City of San Antonio by the last day of the Application period;
- **MUST NOT** have been determined mentally incapacitated by a final judgement of a court;
- **MUST NOT** have been finally convicted of a felony unless probation has been completed. Release from or successful completion of probation or parole does not make a convicted felon eligible for a place on the ballot or able to hold elected office;
- MUST have resided in Texas continuously for one year;
- **MUST** have resided in San Antonio continuously for at least one year prior to filling an Application for a Place on the Ballot;
- **MUST** have resided in the council district he/she hopes to represent at least six months prior to filling an Application for a Place on the Ballot and **MUST** continue to do so during his/her term of office.

* If your area was annexed into the City, you MUST have lived at your residence six months prior to annexation.

CANDIDATE RESIDENCY REQUIREMENTS

In addition to the meeting the above qualifications, Candidates are also required to submit **TWO** of the following supplemental documents verifying residency:

- 1. Valid Bexar County Voter Registration Certificate;
- 2. Current utility bill;
- 3. Current bank statement;
- 4. Government check;
- 5. Original paycheck; or
- 6. Other current government-issued document with name and address.

DEADLINE TO FILE APPLICATION

The deadline to file an Application for a Place on the City of San Antonio's May 3, 2025 General Election Ballot is **5 PM FRIDAY, FEBRUARY 14, 2025.**

Candidates are required to submit the following when applying:

- Completed Application for A Place on the Ballot
- Supplemental Residency documents
- Filing Fee of \$100. CREDIT CARDS ARE NOT ACCEPTED. OR
