ADDRESS: 112 W HOLLYWOOD AVE

APPLICANT: Victoria Gough

#### **REQUEST:**

The applicant is requesting a Certificate of Appropriateness for approval to perform terracing work at the existing front yard berm. The proposed terracing work will begin at the property line at the right of way and extend to the south towards the top of the existing berm.

#### **RECOMMENDATION:**

Staff recommends approval based on findings a through e, as submitted.

APPLICANT: Dennis Oliver

#### REQUEST:

The applicant is requesting a Certificate of Appropriateness for approval to:

- 1. Install a limestone retaining wall.
- 2. Install a landscape bed with steel edging.
- 3. Install Rocky Mountain flat stones at the front yard.

## **RECOMMENDATION:**

Staff recommends approval of items 1 through 3, based on findings a through f, with the following stipulations:

- i. That the applicant reduce the total height of the retaining wall to not exceed the height of slope it retains.
- ii. That the applicant increase the coverage of the Asiatic jasmine, reduce the footprint of the Rocky Mountain flat stones, and provide an updated landscape site plan for review by OHP staff prior to the issuance of a Certificate of Appropriateness.

#### **REQUEST:**

The applicant is requesting a Certificate of Appropriateness for approval to install a 12'0" wide x 20'0" long concrete driveway in front of the primary structure on the NE corner of the property.

#### **RECOMMENDATION:**

Staff does not recommend approval of the request based on findings a and b. Staff recommends the applicant utilize the existing alley-access driveway at the rear of the property.

ADDRESS: 251 BRAHAN BLVD APPLICANT: Damian Gonzales

## **REQUEST:**

The applicant is requesting a Certificate of Appropriateness for approval to:

- 1. Modify the existing front landscape with the installation of plants and grass.
- 2. Install a stucco retaining wall as submitted in the updated drawings, spanning the south property line and not exceeding 3' at any point.
- 3. Install new concrete steps with a stucco retaining wall to the right of the central walkway.
- 4. Install pour-in-place concrete step pads between the left side of the property and central front walkway.
- 5. Install a non-continuous front walkway composed of pour-in-place concrete step pads with shadow stone gravel in between the pads.

#### **RECOMMENDATION:**

Staff recommends approval of items 1-4 based on findings a-d, with the following stipulations:

i. The stucco retaining wall along the south property line match the height specified on the site plan, not to exceed 3' at any point.

Staff does not recommend approval of item 5 based on finding e. Staff recommends the existing solid front walkway be retained or repaired in kind.

## **RECOMMENDATION:**

Staff does not recommend approval of the request, based on the findings. Staff recommends the applicant repair the first-floor wood window in-kind and replace the two one-over-one wood windows on the second floor with a salvaged wood window or a new fully wood window conforming to Guidelines.
