- 2. Kimberly McCleary, Equity Manager with CoSA's Department of Diversity, Equity, Inclusion, and Accessibility, gave a presentation on Diversity, Equity and Inclusion. The notes below are a

- a. Diversity Consider who is in the room. Are there different backgrounds represented?
- b. Inclusion How do the people in the room feel? Do they feel included?
- c. Equity Do the people in the room all have a voice? Are they being heard? Equity is making sure everyone gets what they need.
- d. Equality Everyone gets the exact same thing.
- e. Accessibility Access to the room for people who speak different languages, have different physical abilities, have different hearing and sight abilities.
- f. DEI things to consider: Culture, Benefits vs. Burdens, Access for different languages and physical abilities, Diversity
- g. Focus on outcomes and participation
- h. Inclusion encourages participation
- i. Who is benefiting from something that might burden someone else?
- j. The DEIA office is available as a resource to the committee to discuss issues or answer questions.
- k. Kimberly will review the committee's Guiding Principles and provide feedback.
- 3. Allison Chambers presented a summary of themes from the project reconciliation process that is underway. These themes do not represent specific projects. A list of specific projects will be presented at a later stage after the committee has finished developing the methodology for prioritization of the projects.
 - a. The fourteen themes in no particular order are listed below:
 - i. Stabilize and restore San Antonio River Banks by establishing a riparian buffer along the San Antonio River.
 - ii. Establish protective buffers of vegetation along the length of the river and reconstruct ecosystem integrity and overall plant and animal diversity.
 - iii. Establish the park as a National Historic Landmark and become the first National Heritage Area in Texas.
 - iv. Restore historic buildings (including historic restrooms) and perform a thorough Historic Structures Report (HSR).
 - v. Restore and interpret Spanish Colonial dams, acequias and water works.
 - vi. Interpret archaeological discoveries of historic hydrological structures and create activities for educating and informing the public on archaeology.



- vii. Create an accessible digital repository of historic maps, photographs, postcards, news articles, reports, and plans associated with the park.
- viii. Enhance event spaces for regional use and balance active, passive, and cultural uses of the park.
- ix. Create additional activities for daily use, and include park uses needed by the surrounding neighborhoods.
- x. Limit the new buildings in the park. The master plan calls for only a handful of new facilities, the majority of which are replacements for existing buildings.
- xi. Incorporate cultural institutions more closely into the park.
- xii. Increase visibility and pedestrian access to and within the Park by improving edges and entrances, creating additional paths, and building new pedestrian bridges.
- xiii. Develop a more concentrated parking scheme by replacing many parking lots or roadside parking with a few large parking garages.
- xiv. Incorporate low-impact development features into the park.
- 4. Jay Louden reviewed the Guiding Principles with the committee to further develop/discuss any needed edits desired by the committee.
 - a. Marise McDermott said that "Aboriginal people" should be used instead of the phrase "pre-historic use."
 - b. It was suggested that renovations in the park should be "net zero" and take into account climate equity/sustainability.
 - c. Joe Bravo requested that CoSA Stormwater management come to present to the committee on different types of management strategies. SARA is a member of the technical advisory committee and available to answer any questions on water management/drainage strategies.
