Insurance requirements: Prior to the issuance of a permit, the applicant seeking to permit vehicles intended to carry seven thousand (7,000) pounds gross vehicular weight or more shall file with the city clerk of the City of San Antonio evidence of a commercial general (public) liability insurance policy in an amount of not less than five hundred thousand dollars (\$500,000.00) and thereafter keep same in full force and effect with an insurance company authorized to do business in the State of Texas. The policy shall insure the public against any loss or damage that may result to any person or property from the operation of the hauler's collection, transportation and disposal activities. In addition, the hauler utilizing vehicles that are intended to carry seven thousand (7,000) pounds gross vehicular weight or more shall carry business automobile liability coverage for each and every vehicle of that capacity owned or operated by hauler with combined single limits for bodily injury and property damage of not less than five hundred thousand dollars (\$500,000.00). The policies shall contain a provision requiring that the City of San Antonio be provided with thirty (30) days advance notice, in writing, of cancellation or material change in the policies. In the event of cancellation or material change in the hauler's policies, the permit shall be suspended along with hauler's vehicular activities until such time as the hauler can again secure appropriate coverage.
